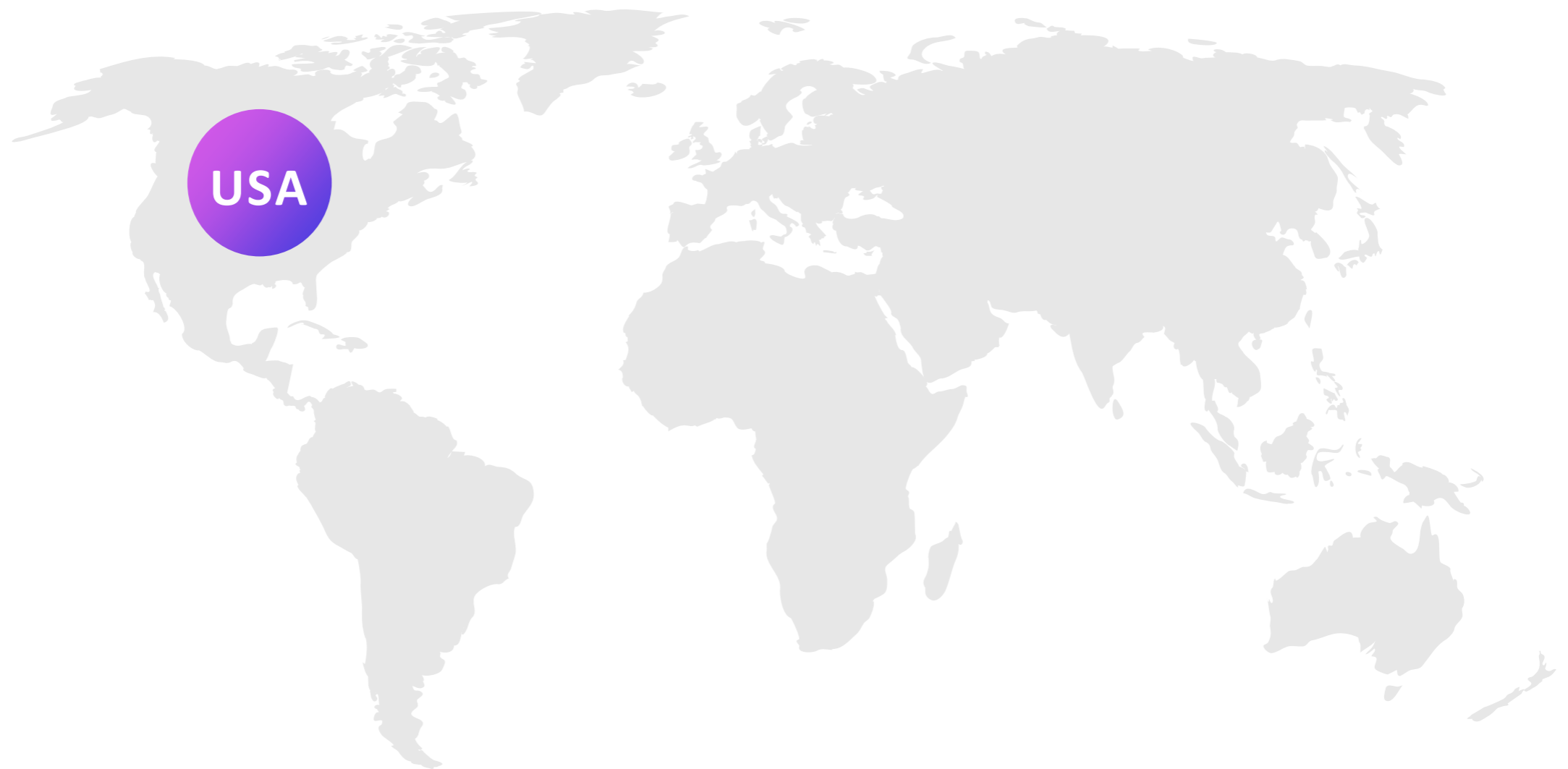
## AlienSquid Top 100 Token Holders

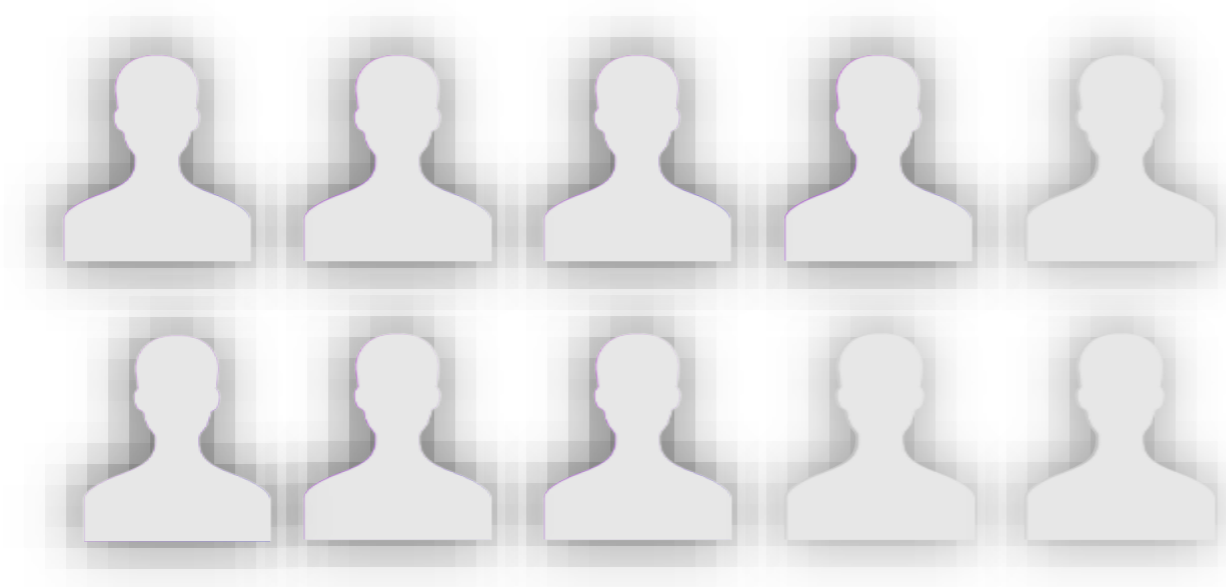
